EURAZEO CONTRIBUTES TO EUROPCAR'S CAPITAL INCREASE

Europear Group, the European leader in vehicle rental service and a major player in mobility markets, has completed a €175 million capital increase by private placement.

A shareholder in the company since 2006, Eurazeo joined the Europear Group's development drive by contributing €30 million to the transaction. Its stake in the Group now stands at 39.22%.

This transaction will help finance Europear Group's external growth policy, notably with a view to acquiring Goldcar, Europe's largest low-cost vehicle leasing company.

A responsible shareholder, Eurazeo's contribution confirms its commitment to assist its companies over the long term with their value creation projects.
