EURAZEO ADDS A PIECE TO ITS INTERNATIONAL COVERAGE BY OPENING A NEW OFFICE IN SEOUL

Paris, September 23, 2019 – The Eurazeo Group is pleased to announce the opening of an office in Seoul to bolster its teams in Asia.

Mr. Philippe Lefort, the French Ambassador in Republic of Korea will be present alongside the company's management team at the office's inauguration on September 24, 2019.
